3. On March 4, 2011, the insurer holding Respondent's surety bond notified the					
Department that Respondent's bail agent	bond was to be cancelled, effective thirty (30) days

- 4. On March 16, 2011, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective April 4, 2011.
  - 5. To date, Respondent has failed to replace the cancelled surety bond.
- 6. Therefore, as of April 4, 2011, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
  - 7. The public health, safety and welfare imperatively require emergency action.

## **CONCLUSIONS OF LAW**

- 1. The Director has jurisdiction.
- 2. Respondent's conduct constitutes a violation of the requirement that each bail bond agent maintain in force while license a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.
- 3. Grounds exist to order a summary suspension within the meaning of A.R.S. § 41-1092.11(B).

## <u>ORDER</u>

## IT IS HEREBY ORDERED THAT:

- Respondent's bail bond agent line of authority under Arizona license number
   207552 is summarily suspended effective immediately.
- 2. Respondent's accident/health and life producer line of authority under Arizona license number 207552 is not suspended.
