On May 11, 2023, CPF Gold Aggregator, L.P. ("Petitioner") submitted an application for the acquisition of control of Gold Kidney of Arizona Inc. ("Insurer") to the Arizona Department of Insurance and Financial Institutions (the "Department") for approval of Petitioner as the controlling person of the Insurer pursuant to the provisions of Arizona Revised Statutes (A.R.S.) §20-1070.

Based upon reliable evidence provided to the Director of Insurance and Financial Institutions ("Director") by the Deputy Assistant Director of the Financial Affairs Division of the Department, the Director finds as follows:

FINDINGS OF FACT

1. The Insurer is a domestic health care services organization as referred to in A.R.S. §20-1051.
2. The Petitioner filed a statement as referred to in A.R.S. §20-1070.
3. The Petitioner has demonstrated that Insurer will continue to maintain the requirements for a certificate of authority as required by A.R.S. §20-1070(D) subsequent to the change in control.

1 4. The failure to adhere to one or more of the above terms and conditions shall
2 result without further proceedings in the suspension or revocation of the Insurer's Certificate of
3 Authority.
